Shipments

Returns

No Product is to be returned to AVT without prior approval from AVT. Product returned for repair, credit, or refund must be properly packed and shipped prepaid to AVT's facility. Product must be returned within 30 days of original shipment to qualify for refund. Credit or refund will only be made after the returned Product has been inspected and tested by AVT. The amount of credit or refund is the sole discretion of AVT.

Warranty
